The organisers of the event (or any of its officials or members) will not be liable or responsible for any personal injury.

Coaches and team leaders are responsible for ensuring that all participants are physically fit, prepared, and capable of coping with the tournament. We strongly recommend proper medical and accident insurance. Competitors compete at their own risk.

5 RULES AND DRAW

The following rules apply:

- JJIF competition rules (in their latest versions) and the Organization and Sporting code of JJIF Version 3.2 (OSC).¹
- We appeal to all participants to respect the fair-play and JJIF book of ethics

5.1 Draw

The draw in block will be made on the 16th of June 2023 at 20:00 hour at the venue².

Immediately after the draw has been finalised, the categories will be made available online on the Sportdata Event Website. JJNOs have the right to request minor changes³ in the following 30 minutes (from 20:00 to 20:30), in writing, to the organising committee.

Major changes⁴ must be requested according to the following⁵:

- At an official international championships, **no redraw** is possible, except for unforeseen cases when the JJIF Board may decide on a redraw.
- A redraw can be requested max. 2 hours after the draw was published but, in any case, before the start of the competition, **in writing**, to the JJEU Sports Director.

5.2 Appeal and Challenge

Will be applied as defined in JJIF OSC 3.2, § 1.5 Challenge and Appeal.

6 RIGHT TO PARTICIPATE AND CATEGORIES

Based on the JJIF OSC 3.2, Paragraph § 3.2. Entries of Competitors:

Each JJNO may enter two (2) contestants in each category for this Europeans Categories

The age following age categories⁶ will be allowed to participate in this event

Name	Description	Year of birth for this event
Adults	18 years and older	2005 - 1925
U21 (+18-21)	18/19/20 years old	2003 / 2004 / 2005
U18 (+16-18)	16/17 years old	2006 / 2007
U16 (+14-16)	14/15 years old	2008 / 2009

Be aware: The Organisation and sporting Code of JJIF **A competitor can participate in only one age category in the same tournament.** Even if the categories are on different days, but within the same event, the same athlete cannot compete in both age categories. For the Europeans NoGi ONLY members of National Federations which are in JJEU can participate.

Official JJIF Weight categories will be used⁷

- ★ Change (of an injured) competitor after registration deadline (in the same category): 10€
- ★ Change of the category of an athlete: 10€
- ★ Late entry: 10€
- ★ Additional entering of a competitor on site: 50€

9 ANTI-DOPING CONTROL

All members should make their competitors aware that there could be doping control for several athletes. The WADA code for Doping Free sports will be applied. By entering the Championship, you accept the JJIF Anti-Doping regulations⁸.

If you are participating in the Championship and are taking any medication or plan to take any medication, please check with your doctor whether your medicine contains any substances on WADA's 2022/2023 Prohibited List.

You will need a Therapeutic Use Exemption (TUE) if it does. JJEU automatically recognises all TUEs issued by National Anti-Doping Agency (NADAs), so please contact your NADA if you need a TUE and do not already have one.

If you have any difficulty applying for a TUE through your NADO or there is no NADO in your country, please contact the JJIF.

10 COMPETITION DRESSING AND PERSONAL REQUIREMENTS & ADVERTISING

Following section 16.11 of the JJIF JiuJitsu rules: Uniform requirements for NO GI competitions:

• Rash Guards: Men and women are required to wear a skin tight shirt that covers the torso and reaches the waistband of the shorts. This shirt must be mostly **red** or mostly **blue**. Competitors are requested to attend the competition with both colors of shirts.

• Shorts: Shorts must be at least to the mid-thigh in length (not exceeding 15 cm from the knee) and must not pass the knee. Shorts may have pockets, but the pockets must be sewn shut and without buttons, exposed drawstrings, and plastic or metal zippers. Compression pants that fit tightly on the skin are permitted under the shorts. All Shorts and tights must be mostly black.

Please observe the regulations of the JJIF as far as advertising on the NoGi is concerned⁹.

11 REFEREES

For these upcoming European Championship, JJEU and the Israelian federation will be able to provide some compensation to the selected referees in terms of travel and accommodation.

The JJEU Board and JJEU Sport Director and a Head referee of JJIF and JJEU are entrusted with the task to select the qualified referees for the event for each discipline at this event.

Referees should attend the briefing meeting on Thursday (15th of JUNE 2023, event is combined tith World CUP JiuJitsu in Gi) afternoon. Referee MUST attend the whole competition at the event, early leaving is NOT possible.

Neither the organizing committee nor the JJEU will be responsible for not respecting this obligation. However, if there won't be enough referees for the competition to take place in good conditions, JJEU Referee Committee may decide to complement the pool of referees with national referees of the organizing federation. For the referees there is a own Sportdata page created, referees must insert themselves and should not be done by the federations.

11.1 Coaches

All official coaches should receive their accreditation cards during accreditation. Teams without an official coach will participate without coaching (no athlete or other officials will be allowed to enter the field of play unless they register as coaches).

11.2 Medical personal

JJNOS may have¹⁰ its medical personnel. To receive an accreditation card as medical personnel the attendance at the medical meeting¹¹ is mandatory.

11.3Dress code

Coaches and medical personnel coming on the FOP must wear official team dresses¹², shorts, flipflops, hats are not allowed.

Filming (including mobile videos) inside the FOP is not allowed without press accreditation.

According to GAISF guidelines, every competitor who has won a medal has to attend the ceremony to receive their trophy in person¹³.

11.4Flags and Anthems

The head of each delegation, or designated responsible of each national federation, must check the flag and the national anthem during the accreditation process.

11.5 Financial conditions

The organisation of the travel to Israel and Travel expenses are the responsibility of the participating countries.

Each federation must pay the cost of the accommodation (if they book the proposed opportunities by the Israelian federation) and the participation to local the organiser.

Payment must be done by bank transfer until 1st of June 2023 or take pre-approval that you will pay cash at the official registration and accreditation.

No registration refund for participants not attending the Championship will be made.
