**From 10th Gup until bis 6th Dan**

Groups will be divided by age and graduation, possibly also by gender.

If there are less than 4 participants, classes will be merged.

Team-Pattern:

**Teams u12,**

**Teams 12 and older up to 3. Gup,**

**Teams 12 and older from 2. Gup to 6. Dan**

A team consists of 3 - 5 participants, regardless of age and gender. The participants must be from the same club.

1 designated pattern will be performed.

Sparring:

(Semi Contact

Point Stopp):

**Kids (up to 11 years)**

Separate classes for boys and girls

Competitors are divided according to graduation and size. The size of the divided category may not be exceeded. In case of less than 4 participants, classes will be merged.

Sparring:

(Light Contact

Continuous):

**12 years and older**

Competitors are ranked according to age, gender, graduation and weight. The weight of the divided category may not be exceeded. In case of less than 4 participants, classes will be merged.
