The organisers of the event (or any of their officials or members) will not be liable or responsible for any personal injury.

Coaches and team leaders are responsible for ensuring that all participants are physically fit, prepared, and capable of coping with the tournament. We strongly recommend proper medical and accident insurance. Competitors compete at their own risk.

#### 4 RULES AND DRAW

The following rules apply:

- JJIF competition rules (in their latest versions) and the Organization and Sporting code of JJIF Version 1.1<sup>1</sup> (SC).
- We appeal to all participants to respect the fair-play and JJIF book of ethics

#### 4.1 Draw modus

The seeding and draw and block will be made on **Friday March the 8<sup>th</sup> of 2024 at 20:00hr** and will be placed online on Sportdata.

Major changes<sup>2</sup> must be requested according to the following<sup>3</sup>:

- At official international championships, **no redraw** is possible, except for unforeseen cases when the JJEU Sportsdirector may decide on a redraw.
- A redraw can be requested max. 2 hours after the draw was published but, in any case, before the start of the competition, **in writing**, to the JJEU Sports Director or JJEU Secretary.

Seeding regulations of the JJIF will be observed. For the seeding in U18/U21 and Adults, JJIF will use the world ranking list and registration to the event from **Friday March the 1<sup>th</sup> of 2024**. The JJNOs are responsible for making sure all points are correct in the raking list until this day.

#### 4.2 Appeal and Challenge

Will be applied as defined in JJIF Sporting Code section Challenge and Appeal.

#### 5 RIGHT TO PARTICIPATE AND CATEGORIES

Based on the JJIF SC 4.0 Entries of Competitors:

#### 5.1 Categories

The age following age categories will be allowed to participate in this event (The SC is applied: U21 can go in Adults)

#### 6 REGISTRATION AND PARTICIPATION FEE

#### 6.1 Registration:

#### 6.2 Participation Fee

**80 euro** per individual DUO/SHOW team U18/U21/Adults 60 euro per individual DUO/SHOW team U16 and U14 *Late entry and late payment fees will be applied.* 

- \* Change (of an injured) competitor until registration deadline: free
- \* Change (of an injured) competitor after registration deadline (in the same category): 10 euro
- \* Change of the category of an athlete: 10 euro.
- \* Late entry: 10 euro
- \* Additional entering of a competitor on site: 50 euro

#### 7 ANTI-DOPING CONTROL

All members should make their competitors aware that there could be doping control for several athletes. The WADA code for Doping Free sports will be applied. By entering the Championship, you accept the JJIF Anti-Doping regulations<sup>4</sup>.

If you are participating in the Championship and are taking any medication or plan to take any medication, please check with your doctor whether your medicine contains any substances on WADA's 2024 Prohibited List

You will need a Therapeutic Use Exemption (TUE) if it does. JJEU automatically recognises all TUEs issued by National Anti-Doping Agency (NADAs), so please contact your NADA if you need a TUE and do not already have one.

If you have any difficulty applying for a TUE through your NADO or there is no NADO in your country, please contact the JJIF.

## 8 COMPETITION DRESSING AND PERSONAL REQUIREMENTS & ADVERTISING

The national federations purchase the back numbers for all JJEU events, at the following link, from Ju-Sports, the premium sponsor of the JJEU:

The JJNOs are then responsible for giving the back numbers to the athletes so that they can apply them to their Gi's prior to the competition. The national federations must pay the back numbers for their athletes by themselves. Participating without an official back number is not allowed.

Please observe the regulations of the JJIF as far as advertising on the Gi is concerned<sup>5</sup>.

#### 9 REFEREES

Application: Referees can register via SportsID for the event. We expect from each participating federation that they will send for 1>5 DUO/SHOW teams 1 referee and for 6>and more at least 2 referees.

All referees will be waitlisted first. For selected referees we offer a hotel room in the official hotel for Saturday and Sunday if requested with full board, but no travel cost. Not selected referees are still welcome to help. A dinner on Saturday is available for all participating referees as also a breakfast on Sunday morning for all referees in the venue.

The TC of JJIF and Head referee of DUO JJEU will decide about participation in consideration of Discipline [s], Availability, License level, Evaluation and Ranking, Gender equality aspects, country. Continental and age mix

#### 10 COACHES & MEDICAL PERSONNEL FROM JJNOS

#### 10.1 Coaches

All official coaches should receive their accreditation cards during accreditation. Teams without an official coach will participate without coaching (no athlete or other officials will be allowed to enter the field of play unless they register as coaches).

#### 10.2 Medical personnel

JJNOS may have their medical personnel. To receive an accreditation card as medical personnel the attendance at the medical meeting is mandatory.

#### 10.3 Dress code

Coaches and medical personnel coming on the FOP must wear official team dresses, shorts, flipflops, hats are not allowed.

Filming (including mobile videos) inside the FOP is not allowed without press accreditation.

According to GAISF guidelines, every competitor who has won a medal has to attend the ceremony to receive their trophy in person<sup>6</sup>.

#### 11 FLAGS AND ANTHEMS

The head of each delegation, or designated responsible of each national federation, must check the flag and the national anthem during the accreditation process.

#### **12 FINANCIAL CONDITIONS**

The organisation of the travel to Belgium and Travel expenses and hotel bookings are the responsibility of the participating countries.

Each federation must pay the cost of the accommodation and the participation to local the organiser.

Payment must be done online on Sportdata (digital paying function by Strip), no bank transfers will be allowed. All payments need to be done until Monday February the 26<sup>th</sup>.

Please note that the JJNOs must fulfil all financial obligations before accreditation.
