Immediately after the draw has been finalised, the categories will be made available online on the Sportdata Event Website..

Major changes<sup>1</sup> must be requested according to the following<sup>2</sup>:

- At official international championships, **no redraw** is possible, except for unforeseen cases when the JJIF Board may decide on a redraw.
- A redraw can be requested max. 2 hours after the draw was published but, in any case, before the start of the competition, in writing, to the JJIF Sports Director.

#### 7.2 Participation Fee

60 euro per individual DUO/SHOW team -

Late entry and late payment fees will be applied.

- \* Change (of an injured) competitor until registration deadline: free
- \* Change (of an injured) competitor after registration deadline (in the same category): 10 euro
- \* Change of the category of an athlete: 10 euro. Late entry: 10 euro
- \* Additional entering of a competitor on site: 50 euro

#### 8 ANTI-DOPING CONTROL

All members should make their competitors aware that there could be doping control for several athletes. The WADA code for Doping Free sports will be applied. By entering the Championship, you accept the JJIF Anti-Doping regulations<sup>3</sup>.

If you are participating in the Championship and are taking any medication or plan to take any medication, please check with your doctor whether your medicine contains any substances on WADA's 2023 Prohibited List

You will need a Therapeutic Use Exemption (TUE) if it does. JJEU automatically recognises all TUEs issued by National Anti-Doping Agency (NADAs), so please contact your NADA if you need a TUE and do not already have one.

If you have any difficulty applying for a TUE through your NADO or there is no NADO in your country, please contact the JJIF.

#### 10 REFEREES

Application: Referees can register via SportsID for the event. We expect from each participating federation that they will send for 1>5 DUO/SHOW teams 1 referee and for 6>and more at least 2 referees.

#### 11 COACHES & MEDICAL PERSONNEL FROM JJNOS

#### 11.1 Coaches

All official coaches should receive their accreditation cards during accreditation. Teams without an official coach will participate without coaching (no athlete or other officials will be allowed to enter the field of play unless they register as coaches). The coaches are also invited to join the referee course on Friday the 10<sup>th</sup>, see details as appendix sent.

#### 11.2 Medical personnel

JJNOS may have their medical personnel. To receive an accreditation card as medical personnel the attendance at the medical meeting is mandatory.

#### 11.3 Dress code

Coaches and medical personnel coming on the FOP must wear official team dresses, shorts, flip-flops, hats are not allowed.

Filming (including mobile videos) inside the FOP is not allowed without press accreditation.

According to GAISF guidelines, every competitor who has won a medal has to attend the ceremony to receive their trophy in person<sup>5</sup>.

#### 12 FLAGS AND ANTHEMS

The head of each delegation, or designated responsible of each national federation, must check the flag and the national anthem during the accreditation process.





#### 13 FINANCIAL CONDITIONS

The organisation of the travel to Belgium and Travel expenses and hotel bookings are the responsibility of the participating countries.

Each federation must pay the cost of the accommodation and the participation to local the organiser.

Payment must be done by bank transfer until Monday January the 30<sup>th</sup> 2023 or take pre-approval that you will pay cash at the official registration and accreditation.
